The 2021 U.S. Capitol Christmas Tree

Every year, a different national forest is selected to provide a tree to appear on the west lawn of the U.S. Capitol building for the holiday season. As many California SAF members know, this year, the tree came from our very own Six Rivers National Forest. Cut on October 23rd, the tree formally began its whistle-stop tour with a visit to Crescent City on the 29th. The tree made its way south from there, making a dozen stops at small towns and big cities throughout our great state. After a week of travel through California, the tree headed east, finishing its journey on November 19th on the West Lawn of U.S. Capitol Building.

California SAF members and leadership met the tree at stops throughout California – including our current Chair, Tim Robards, visiting the tree in Dixon, as well as Past Chairs John Todd and Jay Lopez visiting the tree at its stop in Pasadena (pictured).



California SAF contributed to the U.S. Capitol Christmas Tree's Journey in another way as well. Yours truly (Chair-Elect Rachelle Hedges) had the honor of working with a team from national to develop an informational brochure that accompanied the tree on its journey, as well as a series of <u>FAQs</u> for the U.S. Capitol Christmas Tree website.

Watching the tree travel through our state and seeing the joy it brought to the hundreds of Californians who attended the whistle-stop tour was a wonderful start to the holiday season. The positive media coverage and celebrations that accompanied the tree on its route were a welcomed departure from most of the reporting surrounding California's forests in 2021 – which often felt bleak at best – and served as a good reminder of the positive impacts our forestlands in California have on the citizens of this state. My only disappointment came during the nationally televised tree lighting ceremony, which contained almost no information about the tree or its USFS origins, instead focusing on the trees' final destination on land managed by the National Parks Service. This year's meeting will focus on what we, as a community of interest, can do to advocate for forest management that will help prevent the continued and **unsustainable** loss of our forestlands (and the resources these lands provide) to megafires in California. The meeting will feature presentations by subject matter experts during the first half of the day, and then will see members rolling up their sleeves and getting to work in small group breakout sessions designed to identify and develop the resources needed to assist Cal SAF's membership in advocating for proactive, tangible, and actionable efforts at local, state and regional levels.

As always, an Executive Committee meeting open to all members will be held on Thursday (March 17th), with the larger program held on Friday (March 18th). **More details will be emailed to Cal SAF members in the coming weeks.**

District 3 Board Representative Report

Happy New Year! As we start 2022, we have substantial challenges to meet as we care for our forests. However, these challenges are broadening the importance of the work we do to protect, restore, and utilize our natural resources. I would like to thank all of you who voted in our recent SAF National Election and for maintaining your membership in SAF. One of my primary responsibilities as a Board member is to be a conduit of information between California and Hawaii SAF members and the SAF National Office. In early December, I was able to attend an in-person Board meeting in Washington, D.C., in a shadowing capacity. That trip, and the guidance of prior District 3 Board member, Nick Dennis, have given me the tools to be successful in this position.

So, without further ado, let's get started. Membership in SAF currently stands at 9,399 members. While this number has continued to decline, the decline has lessened, and the number of new members has increased over recent years. During the recent meeting, our consultant, The Moery Company, presented their analysis of the membership survey to the SAF Board and will be following up with SAF staff on recommendations to provide a clear membership structure and value proposition to help all levels of SAF recruit new members and retain existing members.

The 2021 SAF Virtual Convention was a success. SAF2021 Registration is open and on demand content will remain available through January 16, 2022. Recognition of our 2021 award recipients took place during the convention. Several of the award winners provided must-listen videos; to hear them, click on the <u>Wall of Honor</u> link. Please mark your calendars for the 2022 SAF National Convention, scheduled for September 20-24, 2022, in historic Baltimore, Mary-land.

During the December 2021 Board meeting, the Board approved the funding strategy needed to support the previously approved five-year staff and program restructuring plan for 2022-2026. This plan adds staff to improve program delivery and innovation in how SAF supports its members and the profession. The approved funding strategy includes making use of our investment performance over recent years. We will draw the additional \$1.7 million needed to fund these positions over the next 5 years and place the funds in a money market account. Each year the SAF Board will review and approved these funds as part of the annual budget process.

In the 2022 budget, the Board also approved funds to pay for Directors and Officers insurance for all Executive Committee members at the State, Division, and Chapter levels. This insurance provides an added layer of personal protection for our volunteer leaders who are stepping up to serve SAF and its members.

One of the bonuses I enjoyed when traveling to DC was getting to see again the National Christmas tree (*aka Sugar Bear*), in all its glory, on the National Capitol lawn. Congratulations and many thanks to the USFS staff from the Six Rivers National Forest who made the long trip across the country representing California forests at every stop!

In closing, I would like to thank Nick Dennis for his strong representation of California and Hawaii SAF for the past three years. Nick did an excellent job of prompting and assisting Cal SAF leadership when needed and keeping Western forestry issues front and center at the National Office. I look forward to representing you on the SAF Board of Directors.

Report From the Bay Area Chapter's November Meeting

For those of you who could not make November's meeting, we enjoyed a very nice evening shared with the Cal Forestry Club. They hosted us for one of their traditional bean feeds. The weather cooperated with a gorgeous evening outside. After the meal, the group completed an activity that I hope all our members might give some thought to doing. Each person was given a small index card and instructions to answer three questions as succinctly as possible (the "30-second elevator pitch"):

- How does forestry as a career choice fulfill you?
- How do you define forest sustainability?
- What short motto or phrase would you put on a bumper sticker in support of forestry?

I am hoping to use these answers to help us to develop talking points for outreach to students to consider forestry as a field of study and for use in talking with the public. Who knows, we might even get some bumper stickers made!!!

Bay Area Chapter Plans for 2022

On December 7th, the Chapter leadership got together and discussed our plans for 2022. I think we came up with some really good ideas for Chapter meetings and activities for the new year (starting with our first meeting on January 27th). We agreed to hold virtual meetings as well as in-person meetings throughout the year. Let us know if you have ideas for additional Chapter meetings or if you want to assist with any of these meetings.

Some of the meetings we will be working on:

- An update on Bay Area tree mortality as a follow-up to last year's meeting what's been learned about the causes, what new mortality is being seen (like all the pine mortality along the Hwy 24 corridor in the East Bay).
- A field meeting in the East Bay to look at forest restoration and what the term means to different landowners and what it looks like in practice.
- A Spring in-person meeting with the Cal Forestry Club; maybe including another Chapter work day at Russell Research Station.
- A visit to vineyards in the Napa area to discuss wildfires and the effects on vineyards and wine quality. Wine tasting may be involved....
- Meeting with Forest Service leadership in Regional Office in Vallejo to discuss restoration/infrastructure funding and other issues.
- Field visit to fuelbreaks and prescribed fires implemented by Moraga Orinda Fire District
- Field meeting with Marin Municipal Water District or San Francisco Water District to see their land management and discuss current issues.

- Field meeting with Marin Municipal Water District or San Francisco Water District to see their land management and discuss current issues.
- Field visit to Pescadero Creek County Park in Big Creek to discuss wildfire effects and restoration after the fires.
- Virtual meetings that will highlight the work of forestry-related companies based here in the Bay Area (and that employ Chapter members), such as the Pacific Forest Trust, Scientific Certification Systems, New Forests, and Silva Terra.
- In addition, we will still need to get planning on the Student Hiring Fair that we hope to host in October 2022 (crossing our fingers that the University will allow in-person meetings again by then) a focus on forestry and land management internships or jobs in the Bay Area.
