

<u>California Society of American Foresters</u> 2020 Fall Meeting – "Innovation in the Wood Supply Chain" Virtual Field & Facility Tours of Innovation in Practice Thursday October 1<sup>st</sup> & Friday October 2<sup>nd</sup>, 2020 Mare Island, San Luis Obispo, Redding and Cyberspace

**Business innovation** is when an organization introduces new processes, services, or products to affect positive change in their business. This can include improving existing methods or practices, or starting from scratch. "Innovation in the Wood Supply Chain" will be the topic of our **annual fall meeting of the California Society of American Foresters,** as we explore the latest innovations from stump to final products. The 2020 fall meeting replaces our usual field-based summer meeting. We will innovate too, by holding a virtual meeting where we will visit three locations across California with time for question and answer sessions. We will also have time for chats with the whole group or in rooms that will host informal breakout groups. Catch up with colleagues, ask about jobs or recruit new employees, discuss log prices or fires, latest recipes, etc. Our conference this fall will be about innovation, something California has in abundance. Innovation in forest and wood management are an integral part of restoring forest health and resiliency, join us for the conversation.

**Thursday** will start off with the Cal SAF Executive Committee (EC) meeting. The EC meeting will be held on Zoom. The meeting is open to all interested members but motions and voting is limited to EC members.

The usual **Thursday Evening** social will be cancelled this year to avoid teleconference burnout. Your eyes and back need a chance to recuperate for Friday's events.

**Friday** will be a virtual carpool around the great state of California.

Stop #1 on Friday will be the **Factory OS** facility located on Mare Island, Vallejo. Factory OS builds multifamily modular buildings. Factory OS won the Ivory Prize in 2019 in the construction & design focus area, in recognition of their national leadership in industrialized construction techniques.

Stop #2 will be at **Pacific Coast Lumber** (PCL) in San Luis Obispo. Since 1996 PCL has tapped into the vast underutilized resource in local urban forest trees. They produce custom products and services including milling, kiln drying, finished products and outdoor structures.

Stop #3 will be with the Shasta College's Heavy Equipment Logging Operations (HELO) program, which provides students the opportunity to pursue rewarding careers in the forest management and logging industry.
