### SAF National Convention Report By John Todd

The Society of American Foresters welcomed members to Loveland, Colorado for its National Convention on September 17-20, 2024. This year's convention was different from recent events as we did not convene in a single downtown convention center. This year's venue was split between the Embassy Suites Conference Center and the adjacent Ranch Events Complex in Loveland, which sits due east of Rocky Mountain National Park.

Over 1600 people attended this year's convention. Among the attendees were many young professionals and over 500 students. Attendees enjoyed three plenary sessions, field tours, scientific and technical sessions, policy discussions, alumni socials, and many other informative and fun activities.

Directly preceding the convention, the House of Society Delegates (HSD) convened in Loveland for an all-day session. State Society Chairs and Chairelects attend HSD and during the meeting they share both success stories and address challenges that state societies face. This year's productive meeting, led by HSD Chair Logan Nutt, saw greater attendance and participation than in recent years. One of the pleasures of attending the convention is seeing long-time colleagues from across the country, while also spending time with members of your own state society. Cal SAF was well represented in Loveland with faculty representatives from our California universities and many members from up and down the state. A final highlight was seeing our California members receive national awards. Congratulations to both William (Bill) Keye and Jonathan (Jon) Jue for becoming SAF Fellows and to Ricky Satomi for receiving the Presidential Field Forester Award for SAF District 3.

Next year's SAF National Convention will take place October 22-25, 2025, at the Hartford Convention Center, in Hartford, Connecticut. Come and be a part of the festivities as we celebrate SAF's 125th anniversary.

At lunch, we heard from Yosemite Stanislaus Solutions about their experiences with collaborative forest management work at the local level. Finally, Mike Albrecht took us on a tour of an active logging site where we heard about the operations side of forest resilience treatments. Overall, it was a fun and educational day! Thanks to Chair Elect Ricky Satomi for organizing a great meeting.

Sacramento-Tahoe Chapter 3rd Quarter Activities by Gary Brittner

In May 2024, a survey of 6 questions was sent out to the 99 Chapter members. The purpose of the survey was to assist in determining how the Chapter activities could be improved to meet the needs of the members. About 31 responses were received. Members wanted to have field trips or a combination of in-person meetings, field trips and/or teleconference meetings. The respondents wanted to have the meetings have a forestry related speaker or topic. The members wanted to have networking opportunities. 21 of the respondents were still working in the forestry profession and the other 10 respondents were retired. Most of the respondents were not interested in being a Chapter officer.

On July 2, 2024, a small group of members met to plan future meetings and field trips for the Chapter. The meeting attendees included Jane LaBoa, Doug Wickizer, Steve Jones, John Bradford and Jon Jue.

We talked about having Helena Murray, current Chair of the California Society provide an update for what is going on at a future Chapter meeting, which might be a zoom meeting. Chair Murray was contacted and she said that she would be able to give the Chapter an update for Society activities and plans. Other meeting topics included a Forest Service update for Region 5, a Cal Fire update, a California Licensed Foresters Association update with Kathleen Burr, a Board of Forestry update with J. Lopez and a meeting topic of the Forest Service reforestation on the California National Forests. Other field trip opportunities included Blodgett Forest Research Station, the Rio Bravo biomass cogeneration plant in Lincoln, the Forest Service Placerville Nursery in Camino and prescribed burning conducted on privately owned forest lands under the guidance of the **Placer County Resource** Conservation District.

We also talked about providing a stipend for student members to continue their SAF membership instead of providing a scholarship. We also discussed subsidizing attendance for student members to a State Society meeting in the future.

The Chapter did make plans to have a tour of the Placerville Nursery on October 26, 2024. We are still working out the details for timing. The Placerville Nursery was opened in 1957. It covers 157 acres and provided 18 million seedlings annually during peak production. The Placerville Nursery is one of the 6 operational Forest Service nurseries. Currently, it provides about 4 million seedlings annually for reforestation efforts on lands affected by wildfires and insect mortality. The clients served by the nursey include the 18 National Forests in California and the El Dorado Resource Conservation District, which provides seedlings to nonindustrial private landowners. You are welcome to volunteer for any "job" that is best for your schedule and interest. A <u>list of</u> <u>jobs</u>, including the duties and hours for each, is linked on the volunteer form.

The Forestry Challenge is an academic event for high school students in technical forestry and current forestry topics. Participants spend four days in the forest learning about the ecology and management of the forested landscapes that provide communities with water, recreational opportunities, wood products, and wildlife habitat. The Forestry Challenge opens the eyes of hundreds of high school students to education and career pathways in forestry and natural resources. I recently arranged a dinner for several Forestry Challenge alumni who were working summer forestry jobs while pursuing forestry degrees.

John Todd is ending his three-year term with the Society of American Foresters (SAF) Delegates District 3. John has been a member of SAF for decades and served multiple positions with both the Southern California SAF and CalSAF. John represented the state chapter in Washington D.C. He worked closely with the National Office leading the way for CalSAF becoming Incorporated with the National Chapter. John contributed regularly for the CalSAF newsletter, BOD and EC meetings.

Julie Lydick retired from the Awards Chair position. She held the position as awards chair liaison with the national office and state chapter over fifteen years. She guided members and the BOD through application process for nominations, provided feedback, advice and expertise. She regularly provided updates at Executive Committee meetings, contributed to the newsletter and presented at state chapter meetings. Dave Bakke stepped down from the Webmaster role with the state website. Dave supported the website for over three years as editor and contributor. He been a longtime volunteer with CalSAF, dedicating over nine years leading the Bay Area Chapter and a member of the state leadership team for the 2023 National Convention in Sacramento.
